COURSES OFFERED

The College offers full time regular courses :-

- a. Five Year Integrated B.A.LL.B. (Hons)
- b. LL.B. (Three Years)

The duration of the above mentioned degree course shall be for a period of Five years and Three years respectively. Each academic year is divided into two semesters. The academic term shall ordinarily be between July to December and January to June.

Both the courses are full-time course and no student is permitted to pursue simultaneously any other course. Admission of student can be cancelled at any stage for violation of this rule.

As Per BCI guidelines, no students of any degree program shall be allowed to take the end semester examination if the student concerned has not attended minimum of 75% of the class held in the subject concerned. In any exceptional cases, the principal at his discretion may allow those student with attendance of at least 65% of the class held in the subject and not below that.

ELIGIBILITY FOR ADMISSION

B.A., LL.B (HONS.)

As per Bar Council of India (B.C.I.) Rules, a candidate opting for admission to the Five year course must have passed the Higher Secondary Examination (10+2) or its equivalent examination securing in aggregate not below 45% of the total marks in case of general category candidates, 40% of the total marks in case of SC, ST & OBC candidate.

LL.B

As per Bar Council of India (B.C.I.) rules, a candidate opting for admission to the Three year course must be a graduate in any discipline from a recognized University with at least 45% aggregate marks in case of general category candidates, 40% of the total marks in case of SC, ST & OBC candidate.

ADMISSION PROCEDURE

Admission into the 1st semester of B.A., LL. B (Hons.)/LL.B. Courses shall be on the basis of Ajmal Law College Entrance Test (ALCET) conducted by the college. (Admission will be purely on Entrance test.) Candidates who have appeared for the qualifying examination [i.e. (10+2) & UG final Semester respectively for 5years. B.A., LL. B (Hons.) & 3 years LL.B.] are also eligible to appear in the entrance examination.

The examination is to be answered in English only. The result of the entrance examination and the merit list will be put up in the college notice board and the website. Candidates desiring to appear in the entrance examination should fill up the online registration form. The admission forms and prospectus would be available in the college office and can be collected on payment of Rs. 500/- only and the same is also available in the college website.

- e. Aadhar Card f. PAN Card.

- b. Pass certificate and Mark sheet of H.S.L.C. or equivalent examination.
- c. Pass certificate, Registration certificate and Mark sheet of Degree examination or equivalent examination.
- d. Migration certificate for other state students and other Boards students, except Gauhati University.
- e. Aadhar Card f. PAN Card.

Reservation Policy

Reservation of seats for the students of reserved category will be according to the existing reservation policy of the Govt. of Assam and Gauhati University.

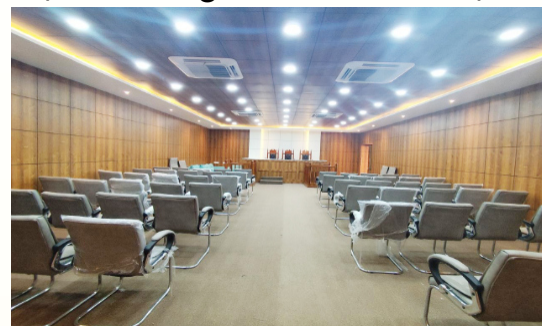
INFRASTRUCTURAL FACILITIES:

MOOT COURT

The term Moot Court basically implies a replica of a legal court, by making pre-trial preparations and letting them have an experience on trial proceedings. Moot court as per BCI rules under part I, provides to consist of 30 marks.

Every student will be made to participate in at least 3 Moot courts on (in) a year with 10 marks, for each assigned problem and it will be evaluated for 5 marks for written submission and 5 marks for oral advocacy. It is also popularly known as Mock Court. Herein students themselves act like Advocates, presenting their arguments and evidences etc.

Mooting allows the students to practice the art of advocacy and the College lays great emphasis on it as it equips the students for their future profession. To be a successful Mooter one should be articulate, well acquainted with Laws, be a cogent speaker with confidence.



LIBRARY

Keeping in mind the importance of a well equipped library in a legal institution, the College has given the library top priority in funding allocations. The College library has a variety of books - both relating to Law as well as the Social Sciences. There are more than 2000 books and journals amounting upto several lakhs of rupees. New books are continuously added to this impressive collection.



LEGAL AID CELL

The College has a well equipped Legal Aid Cell, which was inaugurated by Dr. R.C. Barpatragohain, Advocate General of Gauhati High Court on the auspicious occasion of Constitution Day i.e. 26th November' 2018. With the promise of providing "pro-bono" legal advice and litigational assistance to the general public, the cell in collaboration with the District Legal Services Authority has adopted two villages- Dhanuhar Basti and Fakira Basti. The cell also organizes Legal Aid Camps at regular intervals.

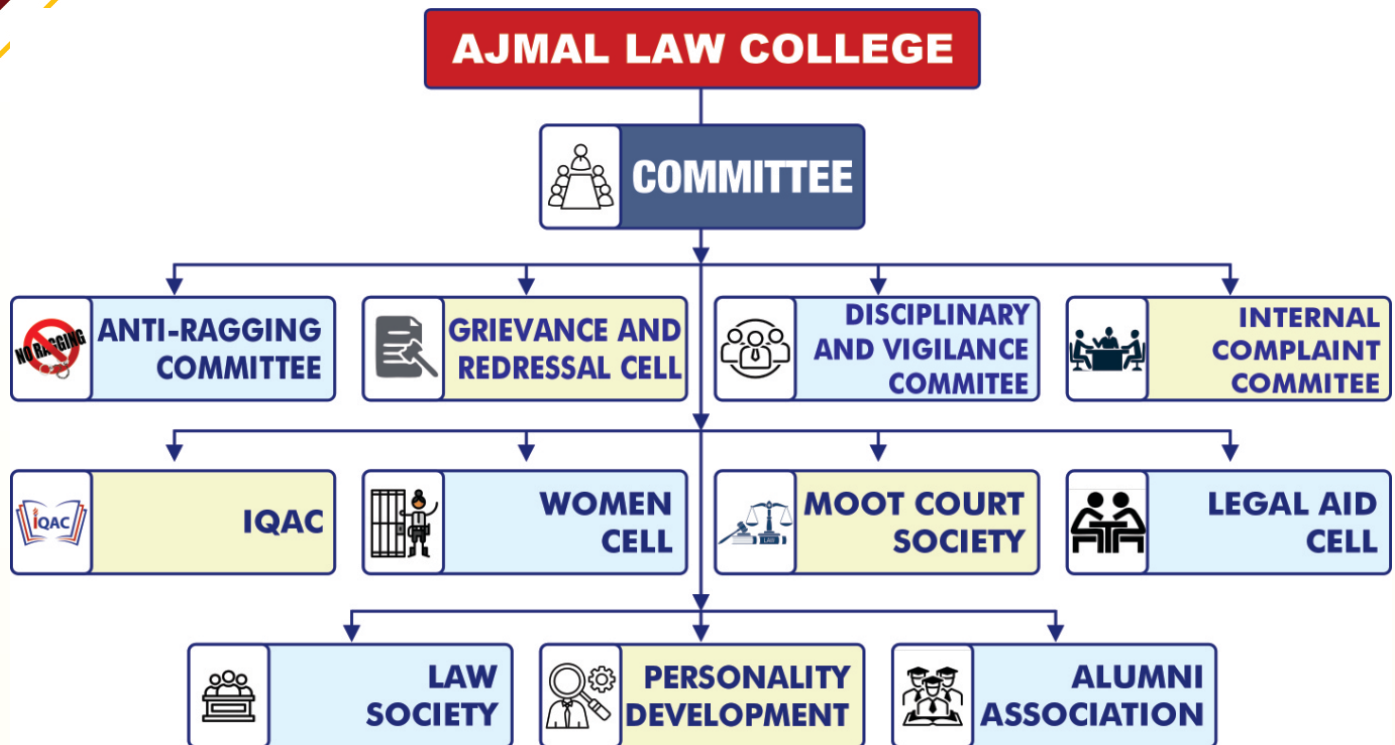
The college offers separate hostels for girls with well-furnished shared rooms. The hostels provide mess facility with healthy and wholesome food.

CODE OF CONDUCT

1. Every student shall maintain a high standard of peace and tranquillity, ideal conduct, cleanliness and discipline in the classroom and within the College campus. No student shall shout and scream or commit acts of misbehaviour with his/her fellow students.
2. Students are expected to maintain strict discipline and order, both on and off campus. The College is a "tobacco-free" zone, so students are not to consume Tobacco, drugs, or alcoholic substances. If they are found consuming any products, the following penalties will be enforced for any violations of this conduct.
 - A. First Violation: Fine of ₹500
 - B. Second Violation: Fine of ₹2,000
 - C. Third Violation: Immediate suspension from the College.
3. Ragging in any form is strictly prohibited and would attract severe disciplinary action. Students found guilty of the same will have to face penal action such as Cancellation of Admission or expulsion from the College.
4. Obscene and indecent behaviour shall invite strict disciplinary action, including expulsion from the College.
5. Sexual harassment, or any practice derogatory to human dignity and personal privacy, is strictly prohibited. Anyone found indulging in such an act would be placed before the committee on sexual harassment of the College for taking immediate & appropriate strong action.
6. The library is maintained and managed under the rules framed by the institution for the library. It is mandatory for all students to strictly adhere to the rules. Non-compliance shall meet strong disciplinary action.
7. The students will be governed by existing Rules, Ordinance and Regulations framed by the Gauhati University, B.C.I. and the College, and the amendments to be affected from time to time.
8. These disciplinary regulations are deemed to be known to all students of the College.



1. ANTI-RAGGING COMMITTEE

'Ragging' is defined as any act that causes or is likely to cause physical, psychological, or physiological harm, apprehension, shame, or embarrassment to a student, and includes (a) teasing, abusing, playing practical jokes on, or inflicting injury to any student. (b) Asking any pupil to do or perform an act that she or he would not normally be willing to do or accomplish. Ragging differs from other crimes in that the motivation is exclusively to gain perverted pleasure.

- "UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". To achieve this objective an Anti-Ragging Committee has been formed by the Institute as per UGC Regulation 2009.
- Zero tolerance to any act associated with ragging and to ensure strict compliance with the provision of UGC regulation 2009.
- Monitor and oversee the performance of the Anti-ragging squad to prevent ragging. The college has taken several steps to stop ragging inside the college premises. During the Orientation Programme, all the freshers are well informed about ragging as well as stern punitive penal action.

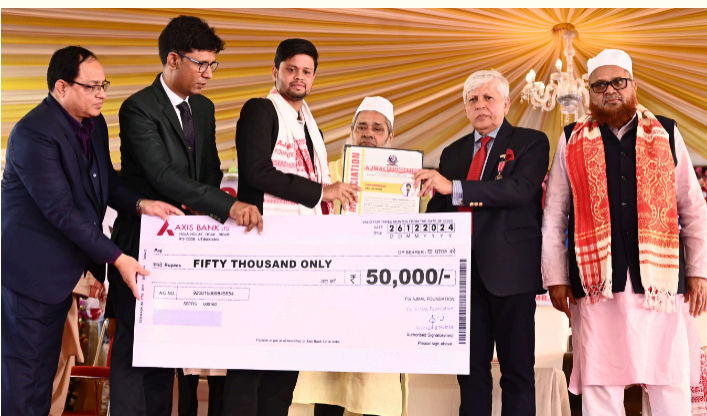
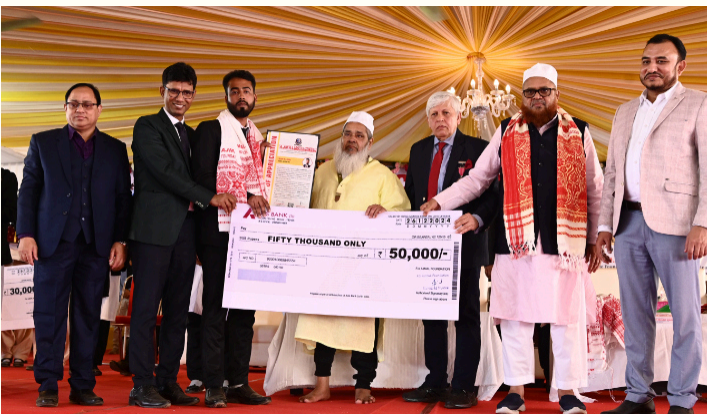

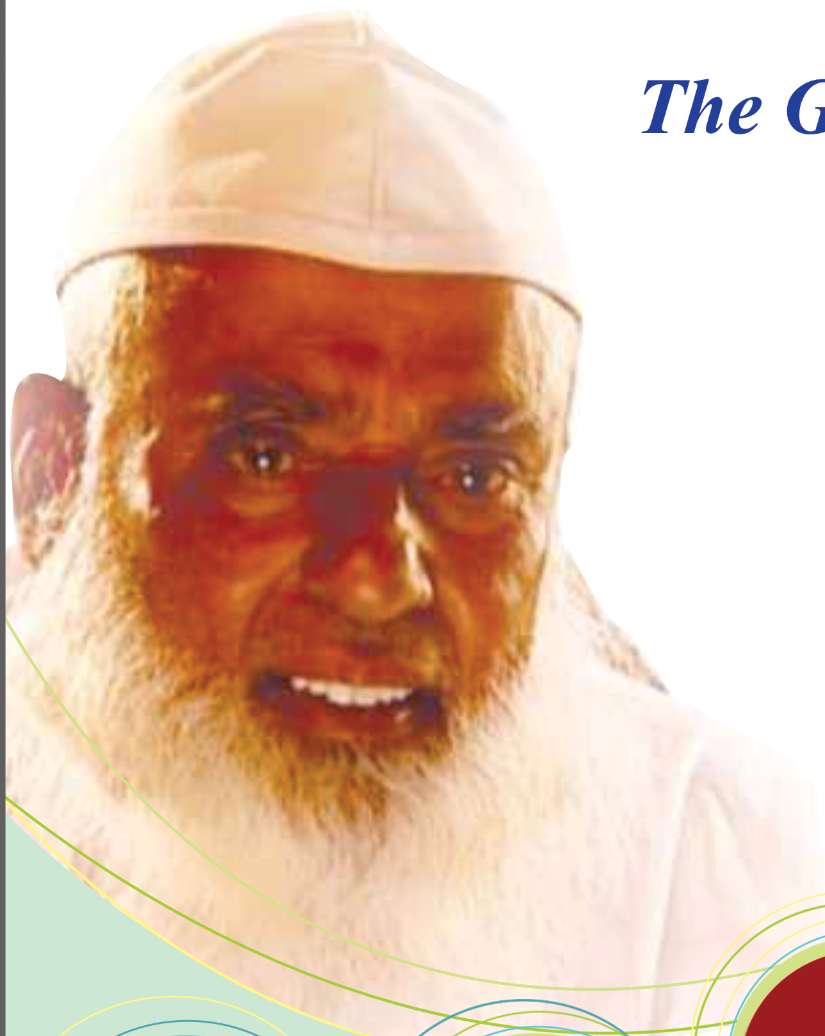
